AMERICAN NATIONAL ELECTION STUDY, 1980: MAJOR PANEL FILE (ICPSR 7763)

The American National Election Study, 1980, consists of eight integrated survey data collections occuring at strategically chosen periods in the course of the election year. Four areas were targeted for special attention: new measurement of party identification, the measurement of voter attitudes concerning issues of public policy, new content concerning public perceptions of and reponses to political leadership, and the exploration of social networks in the crystallization of the vote choice.

Four of the data collections involved a year-long panel. The panel began in late January as national cross-section of 1,008 cases. Interviewing for the first wave, P-1, ended before the New Hampshire primary on February 24. Respondents from this first data collection were reinterviewed in June immediately after the last set of primary elections, which were held on June 3. In this wave, known as P-2, 843 respondents were interviewed. The third panel interview, P-3, was taken during the month of September, when 769 respondents were reinterviewed. The fourth and final panel element, P-4, was taken immediately after the election and consists of 764 cases, including reinterviews with panel members who did not participate in P-3. was a fifteen minute telephone interview. 733 respondents completed all four interviews.

This file contains data for the four panel waves merged into a single record for each of the 1,008 panel participants. The file contains approximately 1,900 variables and is available in card-image and Osiris formats. Class I

CANADA, 1977 (ICPSR 7879)

The Quality of Life Project is a five year research program that began in 1976 and was officially titled "Social Change in Canada: Trends in Attitudes, Values, and Perceptions." The overall purpose of The overall purpose of the project was to develop time series measures of perceived quality of life and of other subjective social indicators for Canada and its major regions.

The data were gathered in sample surveys of the general public of Canada and of selected Canadian decision-makers from a number of institutional sectors. Three national surveys took place in the years 1977, 1979, and 1981, each containing approximately 650 variables and including more than three thousand respondents. A panel of about two thousand respondents is being followed through the three sets of interviews. Surveys decision-makers took place in 1977 and 1981 and will provide for comparisons between the general public and top business executives, politicians, civil servants, and trade union leaders.

The survey data for the project were collected through the Survey Research Centre at the Institute York University, for Behavioural Research, Downsview, Ontario. The 1977 data are currently available with accompanying SPSS control cards. There are 14 decks of data for each of the 3,288 respondents. Class IV

Veroff, Joseph, Elizabeth Douvan, and Richard Kulka; AMERICANS VIEW THEIR MENTAL HEALTH, 1976 (ICPSR 7948)

Funded in 1975 by the National Institute of Mental Health, this data collection proposed to assess the quality of American life and to influence national policy aimed at enhancing mental health resources. In this collection are 262 variables which were also included in AMERICANS VIEW THEIR MENTAL HEALTH, 1957 (ICPSR 3503). In addition, extensive information fix was collected concerning help-seeking, the readiness of people to use professional help, the particular helpers they used, referral mechanisms, and evaluation of help received. There are 2,264 cases and approximately 850 variables. Class I.

Veroff, Joseph, Elizabeth Douvan, and Richard Kulka; AMERICANS VIEW THEIR MENTAL HEALTH, 1957 AND 1976: SELECTED VARIABLES (ICPSR 7949)

This dataset is a collection of 262 comparable variables from AMERICANS VIEW THEIR MENTAL HEALTH, 1957 (ICPSR 3503) and AMERICANS VIEW THEIR MENTAL HEALTH, 1976 (ICPSR 7948). In each of the central areas, investigators were interested in determining whether the 1957 descriptive findings remained stable or had changed by 1976, and whether relationships established between sex, age, education, well-being, role experience, problems, and methods of dealing with stress were replicated or altered in the 1976 results. This is not a panel study. There are 4,724 cases and 262 variables. Class II.

Shanas, Ethel; NATIONAL SURVEY OF THE AGED, 1975 (ICPSR 7945)

This survey of Americans 65 years of age and over is especially concerned with the economic needs and social concerns of the elderly. Included are such variables as number and proximity of children, financial security, income type, religious preference, subjective sense of loneliness and usefulness, age, and perceived degree of filial affection. The data collection is comprised of three parts. Part 1 is the general survey; it contains 549 variables for 2,143 cases. Part 2 is a survey of 103 proxy respondents and contains 45 variables. Part 3 contains information "noncontacts"; it has 30 variables and 602 cases.

National Center for Health Statistics; NATIONAL SURVEY OF FAMILY GROWTH, CYCLE I, 1973 (ICPSR 7898)

The Family Growth Survey is a cyclic survey of civilian non-institutionalized women living in the United States who are less than 45 years of age and who are currently married, previously married, or single with natural children presently living in the household. Data were collected by personal interviews using a probability sample of these women. Fieldwork for Cycle I was conducted in a period centering on September, 1973, and yielded 9,797 interviews. The study includes data on maternal and child health, and family planning practices and attitudes. The data are in logical record length format and contain approximately 1500 variables. Class III

National Center for Health Statistics; NATIONAL SURVEY OF FAMILY GROWTH, CYCLE II, 1976: COUPLE FILE (ICPSR 7902)

The Survey of Family Growth was designed to provide data on fertility, family planning, and related aspects of maternal and child health. Fieldwork for Cycle II was carried out between January and September of 1976. Interviews were conducted with a probability sample of women living in the United States, aged 15 to 45 inclusive, who were either currently married, previously married or never married but had offspring presently living in the household. Questions dealt with respondents' pregnancies, health care and family planning practices and attitudes. Interviews were completed with 8,611 women, and there are approximately 1,000 variables. U.S. Dept. of Commerce. Bureau of the Census; CENSUS OF POPULATION AND HOUSING, 1980 [UNITED STATES]: SUMMARY TAPE FILE 1B (ICPSR 7975)

Summary Tape File 1B (STF 1B) is the second computer-readable data file containing detailed tabulations of the nation's population and housing characteristics produced from the 1980 Census. This series is comprised of 52 separate files, one for each state, the District of Columbia and Puerto Rico. At the time of this mailing, data for Alaska, Colorado, Delaware, Hawaii, Idaho, Mississippi, Montana, Nevada, North Dakota, Rhode Island, South Dakota, Utah, Vermont and Wyoming were available. The data are being released on a "flow" basis, with the less populous states generally being prepared and released before the most populous states. Since the arrival of the remaining state files is imminent users should call the ICPSR 1980 Census Hotline at 313/763-3486 for the latest information about data file availability.

The structure of the files of each state are identical, containing 321 substantive data variables as well as standard geographic identification variables. All of the data items contained in STF 1B were tabulated from the "complete count" or "100%" questions included on the 1980 Census questionnaire.

The format of STF1B is identical to STF1A; some of these files have already been released (see the Revisions section of this BULLETIN). The two groups of files differ only in the types of geographical areas for which the summarized data items are presented. STF1B contains summaries for state or state equivalent; SMSA; remainder of state (nonSMSA); county or county segment (in New England); MCD (present in only 20 states); place or place segment within county or MCD; remainder of MCD or remainder of county; tract (BNA) or portion of tract (BNA) within place, place segment and remainder of county or MCD: block (or ED).

Each record comprises 3,276 characters with two record segments of 1,638 characters each; the number of data records in each file varies by state. Class IV

U.S. Dept. of Commerce. Bureau of the Census; CURRENT POPULATION SURVEY: ANNUAL DEMOGRAPHIC FILE, 1981 (ICPSR 7535)

Annual surveys of the population of the United States, conducted by the U.S. Census Bureau, have been obtained for each of the years from 1968 to 1981. These files are often referred to as the March CPS Demographic Suppplements. Contained in the data files are records for families selected in the samples as well as for each person in these families. The survey for 1981 includes such characteristics as age, race, household structure, ethnicity, education, family relationships, occupation, employment history, migration and both cash and non-cash sources of income.

The data for 1981 were supplied to ICPSR by the Bureau of the Census. The file contains 333,680 records, each with a logical record length of 390 characters. Approximately 400 variables are included for each record. Class IV

National Institute of Mental Health/University of Texas at Austin;

MEXICAN ORIGIN PEOPLE IN THE UNITED STATES: AUSTIN (TEXAS) PILOT SURVEY, 1978-1979 (ICPSR 7965)

This study was conducted for the purpose of testing and improving field procedures prior to beginning the Chicano Survey of 1979. It was jointly funded by the National Institute of Mental Health and the University of Texas at Austin. Interviews were conducted in Travis County, Texas, from November, 1978 to February, 1979. The final sample size was 70 respondents. There are 569 variables concerned with family structure, education and ethnicity, employment, income, language spoken and attitudes towards language as well as interviewer observations. The data have a logical record length of 794.

This collection was made available to ICPSR by the National Chicano Research Network located in the Survey Research Center of the Institute for Social Research, The University of Michigan. Class II

Manpower Demonstration Research Corporation; NATIONAL SUPPORTED WORK EVALUATION STUDY, 1975-1979: PUBLIC USE FILES (ICPSR 7865)

The National Supported Work Demonstration (of which this study is an evaluation) was a transitional, subsidized work experience program for four target groups of people with longstanding employment problems: ex-offenders, former drug addicts, women who are long term recipients of welfare benefits, and school dropouts, many with criminal records. For four years, at 15 locations across the country, the program provided up to 12 to 18 months of employment to a total of about 10,000 individuals. In ten of these sites--Atlanta, Chicago, Hartford, Jersey City, Newark, New York, Philadelphia, Oakland, San Francisco and Wisconsin--6,600 eligible applicants were randomly assigned either experimental groups (offered a job in supported work) or to control groups, and an evaluation was conducted on the effects of the Supported Work

At the time of enrollment, each respondent was given a retrospective baseline interview, generally covering the previous two years, which was followed by up to four follow-up interviews scheduled at nine-month intervals. Each interview collected data on demographic characteristics, employment history, job search, mobility, household income, housing, and respondent's drug use. AFDC recipients were further asked about children in school and welfare participation, while all non-AFDC respondents were questioned about any extralegal activities.

Two public use files have been compiled from this data collection, the Supported Work Employment and Earnings File and the Supported Work Deviant Behavior File. Each file contains data for 6,500 persons for up to five interviews. The Employment and Earnings File contains data from all interview modules EXCEPT the drug and crime sections; the Deviant Behavior File contains all variables on the Employment and Earnings File and adds drug and crime information. Each respondent has up to six logical, fixed-length records, with each record corresponding to a completed interview (up to five) and one additional short "cross-document" record.

THESE FILES ARE CURRENTLY AVAILABLE FOUR-BYTE BINARY. They may be read using IBM (compatible) Fortran. Current plans are to provide a character version of the data by late spring. The binary files require three 2400 foot magnetic tapes written at 6250 b.p.i. or 4-6 reels at 1600 b.p.i.

ELECTRIC UTILITY RATE DEMONSTRATION PROJECT: ARIZONA, 1975-1976 (ICPSR 7887)

The Federal Energy Administration, now incorporated into the Department of Energy, initiated a series of studies on customer response to utility regulatory pricing early in 1975. These studies that comprise the Electric Utility Rate Demonstration program had three major objectives: (a) to demonstrate to utilities and to utility regulators the viablity and customer acceptance of innovative electric rates; (b) to gather empirical data on the impact of such rates on customers and class electricity consumption patterns; and (c) to transfer the results of comprehensive analysis of these data nationwide.

Eight demonstration projects of the series are currently available. Wisconsin (ICPSR 7880), Connecticut (ICPSR 7881) and Los Angeles (ICPSR 7864) were released in October, and five additional demonstrations are now being released. demonstration (ICPSR 7882) occurred in 1976 and 1977, and its project participants included the Public Utilities Commission, Dayton Power and Light, Toledo Edison, Buckeye Power and the Corporation. The Rhode Island demonstration (ICPSR 7883) was conducted by the Blackstone Electric Company during 1977 and 1978. The Arkansas Power and Light Company performed the Arkansas demonstration (ICPSR 7884) in 1976-1977. The Oklahoma demonstration (ICPSR 7886) was carried out by the Edmond Municipal Electric Company during 1977-1978. The Arizona Public Service Company handled the Arizona demonstration (ICPSR 7887) in 1975-1976. Each of these demonstration consist of the five parts described below. The exceptions are Rhode Island which has parts one, two and five and Oklahoma which has part one only.

The first part contains customer survey responses on a wide variety of questions that cover attitudes and behavior on energy-related matters as appliance inventories and economic information. Each demonstration used a different interview instrument so there is a great deal of variation in the scope of the questionnaire surveys. The number of interview waves and the existence of control groups varied among the demonstrations. Only part 1 has a machine-readable codebook. Class II

Part 2, the Demographic Data File, contains summary demographic, household, and appliance data for participants in the experiment. Data in this file are stored as 173 character logical records. A demonstration may have up to three records per customer, derived from the pre-test, the mid-experiment and the post-test questionnaire surveys. Class III

Part 3, the Utility Load Data Group, contains the participating utilities net system load. Each record contains 28 days of hourly net system load data for each utility. Utility load data are linked to a customer by utility ID which is contained in both the demographic and utility load file. The data are stored in 4732 character logical records. The number of records in the dataset reflects the number of 28 day cycles that span the demonstration. Class III

Hourly temperature, wind speed, and humidity by appropriate geographic areas are stored in Part 4, the Weather Data Group. Each record contains 28 days of data for a specific weather station. The number of records per weather station is linked to the amount of time a weather station has reported. Weather data are linked to a customer by weather station ID in both the deomgraphic and weather files. The data are stored as 4731 character logical records. The number of records in the dataset is based on the number of weather stations that reported in the demonstration area and the number of 28 day cycles that the demonstration spanned. Class III

The fifth part, the Usage Data Group, has data recording individual consumption of electricity. Each record for a customer contains 28 days of consumption data, usually at hourly intervals. The number of records per customer on this file is relative to the amount of time the customer spent participating in the experiment. A customer's demographic data and usage data are linked by customer ID. The data are stored as 3393 character logical records. The number of records in this dataset is the multiple of the number of participants and the number of 28 day cycles that comprised the demonstration. Class III

The start dates and stop dates that are reported in all five parts of the Electric Utility Rate Demonstrations are essential variables in the linkage process. These variables, used in conjunction with the utility code, weather station identification and customer identification, enable the records of the separate data groups to be matched and merged or subset.

U.S. Dept. of Commerce. Bureau of the Census; CENSUS OF POPULATION AND HOUSING [UNITED STATES], 1980: PERSON AND HOUSING UNIT COUNTS FOR TRACTS AND MINOR CIVIL DIVISIONS (ICPSR 7970)

This special file was prepared by the Bureau of the Census and covers all census tracts and all minor civil divisions or census county divisions in the United States. All persons in the country were included in the file which has counts for total population, population in group quarters, number of total housing units and number of occupied housing units. There are 83,672 records in the file, one for each geographic unit, and each record has a logical record length of 60. Each record is arranged in a sort sequence of record type, state, county and then MCD/CCD or tract. Class IV

U.S. Dept. of Commerce. Bureau of the Census; CURRENT POPULATION SURVEY, MAY 1979 (ICPSR 7974)

The Current Population Survey (CPS) is a household sample survey conducted monthly by the Bureau of the Census to provide estimates of employment, unemployment, and other characteristics of the general labor force, of the population as a whole and of various subgoups in the population. The entire non-institutionalized civilian population of the United States was sampled to obtain the respondents used for this survey. This file for May 1979 has 160,544 records, one for each of the persons 14 years old and over who were interviewed, and provides comprehensive data on the labor force activity of the respondents. Information is given concerning their employment status, occupation, and industry as well as personal characteristics such as sex, race, marital status, relationship, educational background and Spanish origin, if applicable. Data are also provided for total family income, weekly earnings of respondent, dual jobs and reasons for them, days and hours worked per week, earning per hour, union membership, and time of day at which work began and

This file has approximately 500 variables. The data are available in logical record format, with 792 characters of information recorded for each of the survey respondents. Class IV

U.S Dept. of Commerce. Bureau of the Census; CENSUS OF POPULATION AND HOUSING 1980 [UNITED STATES]: 1970-PRE 1980 TRACT RELATIONSHIPS (ICPSR 7913)

This file presents a general comparability between the census tracts in 1970 and the pre-1980 census tracts, which were identified in late 1978 and used in enumerating the 1980 census. The file provides state, county and tract codes for 1970 and pre-1980. In addition, it has the number of pre-1980 census tracts with territory in common with the 1970 tracts and the number of 1970 tracts with territory in common with the pre-1980 tracts. All tracted areas in the United States are covered; there are 44,550 records, each with a logical record length of 72. Class IV

DETROIT AREA STUDY, 1974: A STUDY OF WOMEN'S
LABOR FORCE PARTICIPATION (ICPSR 7901)

The 1974 Detroit Area Study was conducted to gather information on the participation of women in the labor force. The survey traces the job histories of 438 women for up to 14 previous jobs or occupations, measuring the nature of the work, duration of the job, and public or private employment status. The study also includes data on family members. There are 734 variables. The logical record length is 1698 for each of the 438 records in the dataset. Class III

GERIATRIC HOME CARE UTILIZATION: SAN
FRANCISCO, 1968-1975 (ICPSR 7853)

Data were gathered from the case records of 2,436 older adults served by the San Francisco Home Health Services, Inc. between 1968-1975. The natural history of service use from entry to exit is observed, permitting identification of distinct types of service use. The study also documents the status of clients following home care. Variables comparing formal home health services and informal care at home are also included. Each of the 2,436 has a logical record length of 494 and there are 98 variables. Class IV

Social Security Administration; RETIREMENT HISTORY LONGITUDINAL SURVEY, 1977 (ICPSR 7931)

In 1969 the Office of Research and Statistics of the Social Security Administration designed a ten-year longitudinal study to investigate changes in the economic and social characteristics of men and unmarried women, 58-63 years old, as they approached and entered the retirement phase of their lives. A series of surveys of this group was conducted by the U.S. Bureau of the Census, beginning in 1969. The first wave of this longitudinal survey (1969) was intended to gather first-year data as the baseline for future trend analysis on the sample. Surviving members of the original 1969 sample have been interviewed at two-year intervals.

Variables in the files currently available from the ICPSR include education, occupation, retirement benefits, attitudes toward retirement, living expenses, health, income, assets, debts, spouse's earnings, and additional demographics.

Each of the first four waves contains approximately 2,000 variables. The 1969 wave included 11,153 respondents, the 1971 wave included 10,169 respondents, and the 1973 wave included 9,434 respondents. The 1977 wave includes 7,993 cases representing interviews with 7,079 original panel members and 914 surviving spouses. Class IV

U.S. Dept. of Commerce. Bureau of the Census; CENSUS OF POPULATION AND HOUSING, 1970 [UNITED STATES]: FIFTH COUNT EXTRACT (27 STATES) (ICPSR 7966)

These datasets are extracts of the original DUALabs Special Fifth Count ED/BG Summary Tapes. They contain approximately 90 limited demographic and socioeconomic variables for 27 states in the continental United States. Data are available at the county, minor civil division, enumeration district, and block group levels for Total population and Spanish Heritage population. The 27 files, one for each state, are as follows:

Each record in each file has a logical record length of 985 and the number of records varies from 672 in Wyoming to 24,306 in California (a chart is included in the introduction of the codebook).

Bureau of the Census. U.S. Dept. of Commerce; LISTING OF SPLIT PLACES FOR THE PUBLIC LAW 94-171 DATA FILE: PART 90 (ICPSR 7854)

The Census Bureau has produced a file called User Note No. 2 which documents a problem encountered in all but nine states in the PL94-171 series. It is a list of places split across counties or MCD/CCD's which have two partial records but do not have a "part" indicator on either record. Because of the omission of this part indicator, it is not possible to connect the two parts of the same record (place) for analysis purposes. User Note No. 2 will allow researchers to identify these places and use the data for them more easily. The nine states which are NOT affected are: Connecticut, Delaware, Hawaii, Maine, Massachusetts, New Hampshire, New Jersey, Rhode Island and Vermont. The information was used to facilitate Title 1 of the Elementary and Secondary Education Act by the Department of Health, Education and Welfare. The Survey of Income and Education includes questions used in the Current Population Survey and also contains additional exclusive questions covering school enrollment, disability, health insurance, bilingualism, food stamp recipiency, assets and housing costs.

This extract was made from the SIE Rectangular File (ICPSR 7919) by the National Chicano Research Network and includes only those persons who said their ethnicity was either Mexican American, Chicano, Mexican, Mexicano, Puerto Rican, Cuban, Central or South American, or other Spanish. Those who said they were born in Puerto Rico, Cuba, or Mexico were also included. The collection was provided to ICPSR by the National Chicano Research Network located in the Survey Research Center of the Institute for Social Research, The University of Michigan. This extract contains 16,809 cases for all 422 variables of the file. The logical record length is 624. Class II.

U.S. Dept. of Commerce. Bureau of the Census; SURVEY OF INCOME AND EDUCATION, 1976: IMMIGRANT EXTRACT (ICPSR 7917)

This dataset contains information from the Survey of Income and Education (SIE) conducted during the months of April through July of 1976 by the Bureau of the Census for the Department of Health, Education and Welfare (see ICPSR 7634).

The survey served as a supplement to the yearly Current Population Survey and was conducted to obtain reliable state—by-state data on the numbers of children in local areas with family incomes below the federal poverty level. The information was used to facilitate Title 1 of the Elementary and Secondary Education Act by the Department of Health, Education and Welfare. The Survey of Income and Education includes questions used in the Current Population Survey and also contains additional exclusive questions covering school enrollment, disability, health insurance, bilingualism, food stamp recipiency, assets and housing costs.

This extract was made from the SIE Rectangular File (ICPSR 7919) by the National Chicano Research Network and was created by subsetting from the original SIE files only those persons who said they were not born in the U.S. Contains 21,898 cases for all 422 variables in the rectangular file and the logical record length is 624. The data were provided by the National Chicano Research Network located at the Survey Research Center in the Institute of Social Research, The University of Michigan. Class II.

U.S. Dept. of Commerce. Bureau of the Census; SURVEY OF INCOME AND EDUCATION, 1976: WELFARE EXTRACT (ICPSR 7918)

This study, focusing on the welfare and public support system, contains information from the Survey of Income and Education (SIE) conducted during the months of April through July of 1976 by the Department of Health, Education and Welfare (see ICPSR 7634).

The survey served as a supplement to the yearly Current Population Survey and was conducted to obtain reliable state-by-state data on the numbers of children in local areas with family incomes below the federal poverty level. The information was used to facilitate Title 1 of the Elementary and Secondary Education Act by the Department of Health, Education and Welfare. The Survey of Income and Education includes questions used in the Current Population Survey and also contains additional exclusive questions covering school enrollment, disability, health insurance, bilingualism, food stamp recipiency, assets and housing costs.

The National Chicano Research Network made this extract from the SIE Rectangular File (ICPSR 7919) by including only those cases for people who received either of the following types of support: food stamps in 1975 or 1976, public housing, government rent subsidy, railroad retirement, U.S. government SSI, aid to families with dependent children, other public assistance, medicaid, VA, neighborhood health center, free or low cost clinic, other public source, or any public assistance or welfare the previous month. The 110 variables used from the rectangular file were mostly demographic, income-related, and employment-related variables. The extract contains 84,981 cases. The logical record length is 624. The data were provided by the National Chicano Research Network of the Survey Research Center, Institute for Social Research, The University of Michigan. Class II.

1. Please note these errors in the October, 1981 BULLETIN. For the CURRENT POPULATION SURVEY: 1978 (ICPSR 7876), the number of card image equivalents should be 977,000. For the CURRENT POPULATION SURVEY: 1980 (ICPSR 7875), the number of card image equivalents should be 1,134,400.

The name of the Principal Investigator for the HISPANIC SCHOLARS SURVEY, 1973 (ICPSR 7925) was inadvertantly misspelled. It should be Abdin Noboa.

The ELECTRIC UTILITY RATE DEMONSTRATION PROJECT: LOS ANGELES, WISCONSIN AND CONNECTICUT (ICPSR 7864,7880 and 7881) are actually Class III, not Class II.

The Table of Contents incorrectly identified the NATIONAL ELECTION STUDY, 1978: CAMPAIGN MATERIALS as being 1980. The study description has the complete title: AMERICAN NATIONAL ELECTION STUDY, 1978: SUPPLEMENTARY FILE OF CAMPAIGN MATERIALS (ICPSR 7655).

2. Users of the National Longitudinal Surveys of Labor Market Experience, (ICPSR 7610) the Young Women Cohort, should note this error in the data which was supplied to ICPSR. In 1970 the Employer Comparison is incorrect for 749 women who were coded as unemployed and therefore have a value of NA. For the most part these are young women who are entering the labor force for the first time. These individual records may or may not be correct for subsequent years depending on whether their 1971 employer is the same as their 1970 employer. The NLS staff hopes to have this problem corrected by early 1982 and intends to send out the corrected data with the 1980 Young Women's tape. It also appears that the Comparison of Current with Previous Counties of Residence is incorrect for all years. This set of variables should not be used until further notice.

- 3. Users of the NLS data, the Youth Cohort, (ICPSR 7610) should note this error in the sample selection for the data. The error affects persons born in 1964. The original specifications called for selection of youth ages 14-21 by 1/1/79. However, the program created by NORC to select eligible members used BOTH age as of screening (14-21) and year of birth (1957-1964) as criteria. Since most screening took place in the fall of 1978, a number of eligible respondents born in October through December of 1964 were age 13 when screened and had not yet turned 14: these youth were not included in the sample. Cross tabulation of month and year of birth showed that while most months contained about 120 respondents, the cells for October through December of 1964 contained 75, 46, and 27 respondents, respectively. The major ramification of this error is that the mean age on 1/1/79 for those born in 1964 is about one month greater than it should be. The NLS staff is investigating the possibility of reweighting to correct this error.
- 4. There is an error in the GUIDE TO RESOURCES AND SERVICES, 1981-1982 for the description of ICPSR #0018, UNITED STATES CENSUS DATA, 1970. The last paragraph should read "Major data holdings on hand include...Fifth Count Files A and B for the entire United States and File C for Michigan", and not Files B and C for the entire United States.
