The Survey of Income and Program Participation (SIPP): A New Census Bureau Data Source

Introduction

The Survey of Income and Program Participation (SIPP) is a new nationwide survey designed to provide comprehensive information on the economic situation of households and persons in the United States; the first SIPP interviews of 20,000 households were conducted in October 1983. This survey collects detailed information on cash and noncash income, eligibility and participation in various government transfer programs, labor force status, assets and liabilities, and many other topics on a regular basis to learn how changes in people's lives affect their economic well-being. Data from the survey provide a multi-year perspective on changes in income. and their relationship to participation in government programs, changes in household composition and so forth. The data are also useful for studying federal government programs including their cost and effectiveness, and the effect that proposed changes in program regulations and benefit levels have on recipients. Studies of other important national issues, such as tax reform, social security program costs, and national health insurance also can be enhanced by the information from this survey.

Demands for this type of information surfaced in the late 1960s and early 1970s when many government programs were expanded and reorganized. To carry out this work, policy researchers developed microsimulation models to measure the distributional impacts of various alternative program proposals. These models, however, required detailed data to ensure the reliability of the model estimates and since no single survey collected such information, analysts made many assumptions and imputations based on data from surveys designed for other purposes. The most widely used source of income data was the March Income Supplement of the Current Population Survey (CPS). These income data, however, suffered from underreporting and misclassification by

respondents. The only feasible way of obtaining improved measures of cash and noncash income and previously unavailable program-related data was to start a new survey specifically for this purpose.

Consequently, the Department of Health, Education, and Welfare initiated a research program in 1975, the Income Survey Development Program (ISDP), to design a survey to meet these data requirements. Based on experience obtained in the ISDP, planning began in 1982 for implementation in 1983 of the new survey now known as SIPP.

Design Features

The primary goal in designing SIPP was to improve reporting of income and other program-related data and to do it in a way that would allow the analysis of changes over time at a microlevel. This goal was met principally by using a survey design in which the same people are interviewed at relatively short intervals, once every four months, for approximately 2 1/2 years. The reference period for most survey items is the four month period preceding the month of the interview. Sample persons are interviewed at new addresses if they move, and any other persons that they move in with, or vice versa, are also interviewed. In this way, a highly detailed record is built up over time for each person and household in a sample panel. This design minimizes the need for sample persons to recall most of the information for longer than a few months and reduces the number of questions asked in one interview.

To further enhance the estimates of change, particularly year to year change, a new sample panel of approximately 12,000 households is introduced every year. Consequently, two or sometimes three panels are in the field concurrently. Since portions of the sample are the same from one year to the next, year to year change

estimates can be based in part on a direct comparison across two years for the same individuals. The overlapping panel design also allows cross-sectional estimates to be produced from a larger, combined sample that is about double in size when two panels overlap and triple with three overlapping panels.

Survey Content

Each interview is planned to take about thirty minutes of a respondent's time and includes content that is divided into three main groups of questions. The substance of two of these groups should be essentially the same for each interview and for each panel. The third group of questions covers topics that will change in each interview of a panel allowing for the inclusion of some new content, although many of the topics will be repeated across all the panels.

The first group of questions is contained on the control card, a separate document from the questionnaire, which records basic social and demographic characteristics for every person residing at an address (age, race, sex, etc.) as well as some information relating to the housing unit or household. The card has information on each source of income received and the name of each job or business so that this information can be used at the next interview.

The second major group of questions form the core portion of the questionnaire, which is divided into five sections. The core set of questions is asked at the first interview and then updated in each subsequent interview. The first section of the core collects the basic labor force participation data weekly for all job-holders for the four reference months. In addition, this first section of the core collects much of the information on the receipt of income from various sources during the four month reference period. This includes income from government sources such as Aid to Families with Dependent Children, Supplemental Security Income, General Assistance, Unemployment Insurance, and Workmen's Compensation. Respondents are also asked about Social Security, pensions, and other retirement income, about miscellaneous sources of income such as alimony, child support, interest from savings, income for foster child care, educational assistance, and also about noncash benefits such as food stamps, WIC (Women, Infants, and Children Nutrition Program), Medicaid, Medicare, and health insurance coverage.

The second section of the SIPP core qustionnaire collects information associated with wage and salary earnings, including information on industry and occupation as well as hourly earnings for up to two jobs. Section three collects data on self-employment earnings and specific information about the kind of self-employment. Section four is identified as the general amounts section and it itemizes the monthly amounts received from the income sources previously identified in the first section. The fifth and last section of the core questionnaire identifies amounts of income earned from asset holdings such as savings accounts, bonds, stocks, and rental property.

The third major question group consists of the various supplements or "topical modules" that are included in interviews following the initial interview. Depending on

the time available and the length of the modules, more than one may be administered in the same wave. The topical modules cover a variety of issues not covered in the core portion of the questionnaire; these are areas that do not require examination every four months and may use a different reference period than the core questions. Some modules are assigned to only one interview during a panel, while other modules may be repeated. The module data may be analyzed independently or in conjunction with the control card items or core data. Frequently, a module is administered at the same time in concurrent panels so that the data may be combined to improve reliability.

There are both fixed and variable topical modules. The fixed topical modules are designed to be conducted on a regular basis to augment the core data. They are considered necessary to meet the survey's goals and objectives. Although the topics are "fixed," the questions in these modules may be modified from time to time to accommodate conceptual changes or to make improvements in collecting these data. An example of a fixed topical module is the annual "round-up" module on earnings and benefits which contains wages and salary data from W-2 forms and estimates of annual selfemployment income. Another fixed module administered at the same time has property income and taxrelated information such as filing status and taxes paid, to allow the estimation of tax incidence, disposable income, and the simulation of tax policy alternatives.

Contents of the variable topical modules are designed to satisfy the special programmatic needs of other Federal agencies and are added as the survey continues. One example is the child care topical module administered in the 1984 Panel which was developed to obtain information about child care arrangements. Other modules include pension plan coverage, disability status of children, and characteristics of home financing arrangements.

SIPP Data Products

Microdata files from SIPP are available in two forms. The first is the "Relational File", a complex file which organizes the data within sample units on eight record types and provides pointers to describe the relationships between records. The second is the "Rectangular File" developed from the complex file. On this file the appropriate monthly household, family, and income attributes are assigned to each person.

The Relational File affords some processing efficiency and simplifies the analysis of variables that are not person-level characteristics, but the complex structure requires an experienced programmer and is likely to be expensive when using packages such as SAS or SPSS. The Rectangular Files simplify the computer access to SIPP by providing data at the person level but this introduces other complexities when looking at characteristics at other levels. For example, since household information

is carried for each member of the household, the user must be careful not to count that information more than once for each household.

In general, the Relational File requires more work at the computer processing level, but requires less work for getting at concepts. On the other hand, the Rectangular File is easily accessed, but requires more work to assure that the desired characteristics are obtained.

ICPSR is currently distributing both the Rectangular and Relational Files for Waves I-V from the 1984 Panel (see this BULLETIN for an announcement of several of these files). In addition, ICPSR will release the Wave IV Rectangular File combined with its Topical Module imminently. Census Bureau plans call for the release of three more waves of core data from the 1984 panel in the Fall of this year, and for the release of the Wave V Topical

Module around the end of 1986. The remaining five Topical Modules from the 1984 Panel are expected during 1987. The order of their release will depend on the time necessary for various analysts within the Census Bureau to make preliminary assessments of data quality.

Finally, reports which use data collected in the SIPP are available in the Census Bureau's **Current Population Reports**, **Household Economic Studies**, Series P-70, available from the Superintendent of Documents, US Government Printing Office, Washington, DC 20402.

NOTE TO READERS: In an upcoming issue of the BULLETIN, ICPSR hopes to have a description of the University of Wisconsin's SIPP Data Access Project, which offers an innovative means of research access to the SIPP data collection.

GLOSSARY

Each description of a data collection begins with the name of the Principal Investigator (an individual or individuals or an agency), the authoritative title of the collection with qualifications specific to the current release of the data in parentheses if needed, and the ICPSR study number to be used when ordering.

SUMMARY: Used ONLY for new data collections, this is an abstract of the collection describing its purpose and substance.

COLLECTION CHANGES: Used ONLY for revised/updated collections, this describes changes which were made as of this release.

CLASS: Contains the ICPSR class number.

UNIVERSE: Identifies the group of entities which comprise the object of study in a research investigation; the "population" of elements from which a sample is selected.

SAMPLING: Describes the procedures used to extract the sample from the universe.

NOTE: Used to describe details of interest to users.

EXTENT OF COLLECTION: Lists the components of the entire collection including the number of data files as well as files of machine-readable documentation and/or other material. For revised/updated collections, all parts are described even if the modifications occurred in only one part.

DATA FORMAT: Lists ALL the collection's available data formats: (1) OSIRIS, (2) OSIRIS with SPSS Control Cards, (3) Card Image, (4) Card Image with SPSS Control Cards, (5) Logical Record Length, (6) Logical Record Length with SPSS Control Cards, (7) OSIRIS and Card Image, with SPSS Control Cards for each.

THE FOLLOWING CONVENTIONS were used to present the technical information that is described below. Not all collections have entries in all the tagged fields. (1) One-part data collections have one entry; (2) Small multi-part collections have individual entries; (3) Large multi-part collections show only a range of figures for each element in either one entry or several entries if there are several groupings of data. For revised/updated collections, ONLY the parts which were changed are described and the technical information given is for each revised, changed, or added part.

PART #: Gives the official number of the part and a descriptive name for that part.

FILE STRUCTURE: Describes the structure of the part: rectangular, hierarchical, hierarchical in variable blocked format, or relational.

CASES: Indicates the number of units of analysis.

VARIABLES: Gives the number of variables contained in the file(s).

RECORD LENGTH: Gives the number of characters in each physical data record. Where alternate data formats are available, RECORD LENGTH refers to the data in its Logical Record Length or OSIRIS format. RECORD LENGTH for Card Image data is always 80 characters.

RECORDS PER CASE: (1) Gives the number of 80-character card-image records per case when the data are in Card Image format or (2) gives the number of records per case when the data are available in Logical Record Length format.

RELATED PUBLICATIONS: Contains citations to important publications which are based on the data.

Davis, James A., and Tom W. Smith GENERAL SOCIAL SURVEY CUMULATIVE FILE, 1972-1986 (ICPSR 8609)

SUMMARY: The General Social Survey has been conducted by the National Opinion Research Center annually since 1972 except for the years 1979 and 1981. The Roper Center for Public Opinion Research has prepared a cumulative dataset which merges thirteen years of the General Social Survey into a single file, with each year constituting a subfile. The content of each year's survey changes slightly as some items are added to or deleted from the interview schedule. The most notable addition to the 1986 wave of the survey was a group of questions related to the feminization of poverty. Respondents were asked if they had ever received income from various governmental assistence programs or from alimony or child support payments. Attitudes toward welfare were also probed through agreement or disagreement with a series of statements concerning the welfare system. CLASS IV

UNIVERSE: Total noninstitutionalized English-speaking population of the United States, 18 years of age or older. SAMPLING: Modified probability sample with quotas at block level in 1972-1974. One-half block quota and one-half full probability sample in 1975 and 1976. Full probability sample since 1977.

United States Department of Health and Human Services. National Center for Health Statistics. **HEALTH INTERVIEW SURVEY, 1983 (ICPSR 8603)**

SUMMARY: The basic purpose of the Health Interveiw Survey is to obtain information about the amount and distribution of illness, its effects in terms of disability and chronic impairments, and the kind of health services people receive. Household variables in this data collection include type of living quarters, size of family, number of families in household, and geographic region. Person variables include sex, age, race, marital status, veteran status, education, income, industry and occupation codes, and limits on activity. The Condition, Doctor Visit, and Hospital files contain information on each reported condition, two-week doctor visit, or hospitalization (twelve-month recall), respectively. CLASS IV

UNIVERSE: Civilian, noninstitutionalized population of the United States and the District of Columbia from 1,900 geographically defined Primary Sampling Units (PSU). SAMPLING: Multi-stage probability sample.

NOTE: The data contain amp (&), dash (-), and blank codes. In conjunction with the changes made to the core of NHIS in 1982, all 5 types of files have revised tape layouts. In general, identification items are at the beginning of each record followed by household and person information in the same location on each tape. Limitation of activity, acute conditions, disability days, and doctor visits should not be compared to data gathered before 1982.

MONITÓRING THE FUTURE: A CONTINUING STUDY OF THE LIFESTYLES AND VALUES OF YOUTH, 1985 (ICPSR 8546)

SUMMARY: The eleventh annual survey in the Monitoring the Future series continues that series' exploration of changes in many important values, behaviors, and lifestyle orientations of contemporary American youth. A nationally representative sample of high school seniors was asked to respond to a set of drug use and demographic questions. In addition to these "core" questions, which were included in all five questionnaire forms, each of the forms sought student response to questions on certain other subjects. These included attitudes toward government, social institutions, race relations, changing roles for women, educational aspirations, occupational aims, and family plans. CLASS II

CBS News **CBS NEWS NATIONAL SURVEYS, 1985 (ICPSR 8547)**

SUMMARY: CBS News conducted these interviews in 1985 as part of an ongoing data collection effort. Each dataset contains questions of topical relevance or questions which pertain to broader social issues. The hijacking of TWA flight 847 was the focus of the first two surveys. Respondents were asked to evaluate Reagan's handling of the crisis, to give their opinions on how the United States should deal with terrorism and terrorists, and to explain their attitudes about United States policy in the Middle East and media coverage of the event. Attitudes towards air safety, including effects on travel plans, were explored in the third survey. The fourth dealt with the United States/Soviet summit meeting in Geneva. Questions regarding the summit include approval or disapproval of Reagan's handling of the summit, whether and how to negotiate with the Soviet Union, attitudes towards Gorbachev, and the role the leaders' wives played. In the final survey, respondents were queried about professional football—the game, teams, players, coaches, and media coverage. All respondents were asked for demographic information. CLASS IV

SUMMARY: The New York Times conducted interviews with only New York City residents for this survey. Respondents were asked questions concerning their attitudes towards living in New York City, their assessments of city services, and their opinions of New York City leaders and the Governor of New York. In addition, respondents were probed for their opinions on crime and what causes crime in New York City, what measures people take to protect themselves, and whether the respondent or a family member has ever been a victim of a crime. Demographic information is also included. CLASS IV

SUMMARY: CBS News, The New York Times, and Tokyo Broadcasting System conducted a series of interviews in both Japan and the United States in July 1985. Japanese respondents were questioned about their government, the United States, and trade policies of Japan and the United States, as well as their attitudes towards work. They were also asked about the products from the United States they would like to have, their experiences in World War II, and their political knowledge of the United States. Respondents in the United States were surveyed regarding their attitudes towards Japan and Germany, Reagan, and United States-Japan trade policies. They were asked to evaluate Japanese products, compare Japanese and American industry, and give their opinions on tax reform and major league baseball. In addition, American respondents provided information on their political knowledge of Japan and the United States and gave their opinions on events during World War II and on the lasting effects of World War II on attitudes about Japan. Respondents in both countries were asked for demographic information. CLASS IV

SUMMARY: As part of an ongoing data collection effort, a series of interviews was conducted by CBS News and The New York Times. The substantive common denominator in the surveys is a continuing evaluation of the Reagan presidency. Each survey also contains questions of topical relevance or questions about broader social issues. Respondents were queried about their attitudes towards the arms race and "Star Wars," Ronald Reagan and his domestic and foreign policies, tax reform, the federal deficit, the Vietnam War, Reagan's visit to the military cemetery in Bitburg, Central America, trade policies, the United Nations, AIDS, the Soviet Union, and religion and the Catholic church. One survey contains questions concerning race relations and public figures in New York City. Only New York City residents were interviewed for this particular survey. All surveys contain demographic information on respondents. **CLASS IV**

UNIVERSE: Adults in the United States age 18 and over. Part 4: New York City residents age 18 and over. SAMPLING: Stratified random digit dialing.

NOTE TO USERS OF ABC

Some users of ABC have been experiencing problems when trying to run ABC under DOS 3.0 or greater. These problems are only occurring with the 256K version of ABC not the 512K version. This is because the newer, larger version of DOS requires up to 10K more random access memory (RAM) than before and ABC requires at least 225K of RAM. There is simply not enough room in memory on a 256K system for the ABC program as well as DOS 3.0 or greater.

By adding 64K more memory to their microcomputers and upgrading from 256K to 512K, ABC users will be able to use DOS 3.0 and greater. 64K is the smallest increment of memory that can be added to a microcomputer, and is a relatively inexpensive upgrade.

Those considering purchase of ABC for the first time should run this test: Do a CHKDSK (from DOS) to see how much RAM is FREE for loading programs. Systems with 225K or more of memory available can handle ABC; systems with less than 225K will need to be upgraded to 512K before they can run ABC successfully.
