

THROUGH ITS NEWLY ESTAB-LISHED EDUCA-TION ARCHIVE, ICPSR SEEKS TO

preserve and provide access to data on all aspects of the education system in the United States, Working with the National Center for Education Statistics, ICPSR is making available data series that span decades, thus enabling research on a variety of factors that influence educational outcomes.

ICPSR is collaborating with the National Center for Education Statistics (NCES), the primary federal entity for collecting and analyzing data related to education in the United States and other nations, in establishing the International Archive of Education Data (IAED). The archive, which is based at ICPSR, acquires, processes, documents, and disseminates data collected by national, state or provincial, local, and private organizations, pertaining to all levels of education in countries for which data can be made available. Data encompass the "inputs" to education (funding, personnel, teaching resources, facilities, teacher and student preparation, etc.), the variety of processes by which teaching and learning occur, and the "outputs" of education (graduation and matriculation rates, drop-out rates, test scores, job placements, life histories, life assessments, etc.). The data stored in this new archive are intended to support a wide variety of comparative and longitudinal research through the preservation and sharing of data resources. The archive seeks to serve the needs of academics, policymakers, and researchers in the field of education.

on Education

Data from NCES form the initial foundation of the archive. The first and foremost goal of the archive is to preserve all of the NCES public-use research data holdings and to make these holdings, as resources permit, suitably available for research throughout the nation and the world. Some of these data collections are more than 30 years old and exist in a wide variety of data formats. Original documentation in many cases exists only in hardcopy form. This rich public resource comprises much of the statistical history of the federal education establishment in the United States.

## **Processing and Procedures**

During the initial stages of the work, ICPSR has performed several key tasks to preserve NCES data collections and to encourage their research use. All original paper documentation has been preserved and has also been converted into electronic form through scanning procedures using Adobe Acrobat, thus producing files in Portable Document Format (PDF). Archive staff have examined the technical documentation for the presence of required elements (e.g., sampling description, response rates, data collection methods, data collection instruments, codes, etc.) and have checked data files for the presence of undocumented or "wild" codes for categorical variables. In addition, staff have performed confidentiality assessments to determine whether the data elements require treatment to preserve respondent privacy under contemporary standards for reducing the risk of reidentification.

The completion of all processing steps results in easy access to these NCES public-use research datasets. All data collections processed under the project are accompanied by electronic documentation, including (when available) record layout forms, data element descriptions, questionnaires or data collection instruments, attachments, tables, and appendices. Electronic documentation is searchable for text terms if the original materials were of sufficiently high optical quality. In addition:

- With a few exceptions, all datasets are accompanied by SAS input statements.
- All datasets include standard data-finding materials such as study descriptions, thus facilitat-

- ing resource discovery and retrieval through ICPSR's on-line search facilities.
- All NCES data and documentation in the IAED are available at no charge to anyone having access to the World Wide Web, without regard to institutional membership in ICPSR. Alternative physical media are provided at cost upon request.
- All electronic documentation may be browsed and searched on-line.
- Technical user support is provided to all users upon request.
- All data and documentation files are archived in such a manner as to ensure that the data remain available for research for many generations.

#### IAED and NCES Websites

Upon completion of these tasks, all processed datasets and their documentation are made available through the IAED web page on the ICPSR server: http://www.icpsr.umich.edu/IAED/. This website is intended to function as the principal vehicle for IAED activities. It serves as one of the "data access tools" of the National Center for Education Statistics, providing users with historical data to complement the more recent surveys available directly from the NCES website.

One of the distinctive features of the IAED website is its close relation to the online facilities of NCES (http://nces.ed.gov/). The goal is to provide seamless access to educational research resources of all types. In addition to providing a large and ever-increasing number of basic data and documentation files for researchers to perform their own quantitative analyses, the NCES website permits

users to quickly examine and download NCES reports, peruse self-generated statistical information about schools and education policies, and link to a wide variety of other similar sites.

### Libraries

Public Library Survey
 A brief description of each of these data series follows.

#### Common Core of Data (CCD)

The CCD consists of four surveys completed annually by state education departments to report data about all United States public elementary and secondary schools, local education agencies, and state education agencies. Three categories of information are included: a general description of schools and school districts, including name, address, and phone number; data on students and staff, including demographics; and fiscal data, including revenues and current expenditures. Early-release CCD data files are available at the NCES CCD website. The CCD includes four components:

- Public School Universe provides information on all public elementary and secondary schools in operation during a school year, including school location and type, enrollment by grade and student characteristics, and the number of classroom teachers.
- Public Agency Universe includes information for the universe of Local Education Agencies (LEAs), including phone number, location and type of agency, current number of students, and number of high school graduates and completers in the previous year.
- State Nonfiscal Survey aggregates all students and staff to the state level, including number of students by grade level, fulltime equivalent staff by major employment category, and high school graduates and completers in the previous year.
- State Fiscal Survey offers detailed data aggregated to the state level, including average daily attendance, school district revenues by source (local, state, federal), and expenditures by function (instruction, support services, and noninstruction) and subfunction (school administration, etc.).

## Private School Survey (PSS)

The PSS produces information about the number of private schools, students, teachers, and graduates in the United States. The PSS was first conducted in 1989–1990; follow-ups were conducted in 1991–1992, 1993–1994, 1995–1996, and 1997–1998. This survey will be administered every two years, with another round in 1999–2000.

## Schools and Staffing Survey (SASS)

The SASS is an integrated sample survey of public and private schools, public school districts, and principals and teachers. SASS was first administered during the 1987–1988 school year, and again in 1990–1991 and 1993–1994. It will be conducted again in 1999–2000 and in 2003–2004.

# National Household Education Survey (NHES)

The NHES is designed to collect information from households on a variety of educational issues. Surveys were fielded in the spring of 1991, 1993, 1995, and 1996 and will continue to be conducted periodically. The first survey collected information from parents concerning early childhood education. In 1993, parents were asked about the school readiness of their children, and both parents and children were asked about school safety and discipline. The 1995 survey focused on early childhood program participation. Parent involvement in the education of their children and parent civic involvement were addressed in 1996. Youths were interviewed about their civic involvement as well. Information was also collected about household use of public libraries.

## National Assessment of Education Progress (NAEP)

NAEP is designed to continuously monitor the knowledge, skills, and performance of the nation's children and youth. NAEP provides objective data on student performance at national and regional levels in reading, mathematics, science, writing, citizenship, U.S. history, geography, social studies, art, music, literature, computer competence, and career and occupational development.

# Integrated Postsecondary Education Data System (IPEDS)

The IPEDS surveys most postsecondary institutions annually, including universities and colleges, as well as institutions offering technical and vocational education beyond the high school level. IPEDS began in 1986, replacing the Higher Education General Information Survey (HEGIS), which began in 1966. IPEDS includes the following components:

- Earned Degrees/Completions
   offers annual numbers of associate, bachelor's, master's, doctoral, and first-professional
   degrees and other formal
   awards, by institution, 6-digit CIP
   code, and sex of recipient. Also
   provided are awards by racial/
   ethnic composition, program
   area, and sex.
- Fall Enrollment provides annual data on full- and part-time enrollment by racial/ethnic category and sex for undergraduates, first-professional, and graduate students. Age distributions by level of enrollment and sex are collected in odd-numbered years, and first-time degreeseeking student enrollments by residence status are collected in even-numbered years.

- Fall Staff presents the number of institutional staff by occupational activity, full- and part-time status, sex, and race/ethnicity. Data are collected in odd-numbered years. Beginning with 1993, this survey replaces the EEO-6 survey conducted by the Equal Employment Opportunity Commission.
- Finance Statistics includes each institution's current fund revenues by source (e.g., tuition and fees, government, gifts); current fund expenditures by function (e.g., instruction, research); assets and indebtedness; and endowment investments. Data are collected annually.
- Institutional Characteristics/Total Institutional Activity provides information for all postsecondary education institutions in the United States and outlying territories on name and address, congressional district, county, telephone number, tuition, control or affiliation, calendar system, levels of degrees and awards offered, types of programs, credit and contact hour data, and accreditation. Data are collected annually.
- Salaries, Tenure, and Fringe Benefits of Full-Time Instructional
   Faculty presents the number of full-time instructional faculty by rank, sex, tenure status, and length of contract, as well as salaries and fringe benefits. Data are collected annually.

# Higher Education General Information Survey (HEGIS)

HEGIS, the forerunner of IPEDS, constituted an integral part of the comprehensive nationwide system of collecting basic data on higher education widely used by administrators, planners, researchers, and guidance counselors. Composed of a number of distinct surveys, this data series included information such as the number of degrees conferred at institutions of higher education in the United States, revenues and expenditures, enrollment statistics including number of students by residence status, basic characteristics of educational institutions, numbers of full-and part-time employees, and faculty compensation. HEGIS includes the following components:

- Earned Degrees/Completions provides information, by sex and race, on the number of bachelor's, master's, doctor's, and first-professional degrees conferred in selected fields, and degrees and awards conferred based on less than four years of academic work beyond high school.
- Finance covers current fund revenues by source, expenditures by function, land, buildings, equipment assets, balances and transactions on the physical plant, endowments, and changes in fund balance.
- Residence and Migration provides the number of students in enrollment classifications by residence status (in-state/out-of-state/foreign), by home state, and by sex.
- Salaries focuses on compensation of full-time instructional faculty by sex, rank, and length of contract, and may also include tenure and fringe benefits of fulltime instructional faculty and administrators. This component represents a compilation of two surveys used by NCES to collect salary data: "Employees in Higher Education," and "Salaries,

- Tenure, and Fringe Benefits of Full-Time Faculty."
- Fall Enrollment provides fulltime, part-time, and full-timeequivalent enrollment by sex and by race, for undergraduate, graduate, unclassified, and firstprofessional degree students by field of study.
- Institutional Characteristics includes institution name, address, telephone number, congressional district, type of control, level of offerings, types of programs, accreditation, names of principal officers, and previous year enrollment.
- Libraries covers library resources, physical facilities, staffing patterns, salaries and wages, number of employees, level of educational attainment, current expenditures, and learning resource centers.

## National Postsecondary Student Aid Study (NPSAS)

The NPSAS is a comprehensive study that examines how students and their families pay for postsecondary education. It includes nationally representative samples of undergraduate, graduate, and first-professional students attending public and private less-than-two-year institutions, community colleges, four-year colleges, and major universities. Students who receive financial aid as well as those who do not receive financial aid participate in NPSAS. Comprehensive student interviews and administrative records, with exceptional detail concerning student financial aid, are available for academic years 1986-1987, 1989-1990, 1992-1993, and 1995-1996. Another survey round is being conducted in 1999-2000.

## Recent College Graduates (RCG)

The RCG is designed to analyze the occupational outcomes and educational experiences of bachelor's and master's degree recipients who graduated from colleges and universities in the continental United States. The survey was administered during the 1985–1986 academic year and again during the 1989–1990 academic year.

## **Adult Education Surveys**

These surveys, conducted by the Bureau of the Census as part of their Current Population Survey, collected information on participants in adult and continuing education activities throughout the 50 states and the District of Columbia. Information was collected on types of courses taken, types of institutions or agencies offering courses, reasons for taking the courses, and the respondent's age, sex, and race.

## National Longitudinal Study of the High School Class of 1972 (NLS-72)

This survey describes the transition of young adults from high school through postsecondary education and the workplace. The data span 1972 through 1986 and include college transcripts.

## High School and Beyond (HS&B)

The HS&B describes the activities of seniors and sophomores as they progressed through high school, postsecondary education, and into the workplace. The data cover the period 1980 through 1992 and include parent, teacher, and high school transcript data; student financial aid records; and college tran-

scripts, in addition to student questionnaires.

## National Education Longitudinal Study of 1988 (NELS)

Beginning with an 8th-grade cohort in 1988, NELS provides trend data on critical transitions experienced by young people as they develop, attend school, and embark on their careers. Data were collected from students and their parents, teachers, and high school principals and from existing school records such as high school transcripts. Cognitive tests (math, science, reading, and history) were administered during the base year (1988), first follow-up (1990), and second follow-up (1992). Third follow-up data were collected in 1994. All dropouts were retained in the study.

## Public Library Survey

The Public Library Survey collects data annually on the nearly 9,000 local public libraries in the U.S. Data are collected through the Federal State Cooperative System for public library data and cover staffing, service outlets, income and expenditures, collection size, and service measures.

### Additional NCES Surveys

A number of NCES data collections that are sampled surveys of individuals are currently available from NCES as restricted data files. Restrictions apply only to surveys of individuals from 1990 forward; prior survey data are publicly available. #### New Directions for the IAED

Archive staff are continuing to explore new methods of processing and disseminating data collections. For example, documentation for selected datasets will be enhanced to include extensive hyperlinks to permit researchers to move easily from one section of the document to another. In addition, a number of data collections will be incorporated into a Survey Documentation and Analysis System (SDA), which will allow users to subset variables or cases for analyzing or downloading and produce crosstabulations, descriptive statistics, and frequencies.

Perhaps the most important future direction for IAED is the expansion of its collection scope beyond its core of NCES datasets. IAED will increase its contacts with the research community by exhibiting at major education conferences such as the American Educational Research Association's annual meeting in New Orleans, April 24-28, 2000. Additional collections from individual research scholars and data sources from the international arena will allow IAED to fulfill one of its ultimate goals: facilitating comparative research of the educational enterprise.

The International Archive of Education Data staff are eager to hear from researchers about educational data that they would like to see included in the archive and would particularly welcome inquiries from project investigators who wish to deposit their data in the International Archive of Education Data.

American National Election Study, 1998: Post-Election Survey — Virginia Sapiro, Steven J. Rosenstone, and the National Election Studies (ICPSR 2684)

This study is part of a time-series collection of national surveys fielded continuously since 1952. The election studies are designed to present data on Americans' social backgrounds, enduring political predispositions, social and political values, perceptions and evaluations of groups and candidates, opinions on questions of public policy, and participation in political life. Substantive themes of the 1998 election study include, among others, knowledge and evaluation of the House candidates and placement of the candidates on various issue dimensions, interest in the political campaigns, attentiveness to the media's coverage of the campaign, media use, evaluation of the mass media, vote choice, partisanship, and evaluations of the political parties and the party system. Additional items focused on political participation, political mobilization, evaluations of the president and Congress, the "Lewinsky affair," egalitarianism, moral traditionalism, political trust, political efficacy, ideology, cultural pluralism, and political knowledge. Respondents were also asked about their attitudes toward a wide range of issues, including social policy, race policy, military and foreign policy, immigration, foreign imports, prayer in schools, school vouchers, the environment, the death penalty, women's rights, abortion, and religion and politics, including new measures of explicitly political and religious orientations. Demographic items such as age, sex, nationality, marital status, employment status, occupation, and education were also included.

Capital Punishment in the United States, 1973–1997 — United States Department of Justice. Bureau of Justice Statistics (ICPSR 2737)

This data collection provides annual data on prisoners under a sentence of death and prisoners whose offense sentences were commuted or vacated during the period 1973-1997. Information is supplied for basic sociodemographic characteristics such as age, sex, education, and state of incarceration. Criminal history data include prior felony convictions for criminal homicide and legal status at the time of the capital offense. Additional information is available for inmates removed from death row by yearend 1997 and for inmates who were executed.

Comparative Study of Electoral Systems, 1996–2000 —

Comparative Study of Electoral

Systems Secretariat (ICPSR 2683)

This study is an ongoing collaborative program of crossnational research among national election studies designed to advance the understanding of electoral behavior across polities. The data project, which is being carried out in over 50 consolidated and emerging democracies, was coordinated by social scientists from around the world who cooperated to specify the research agenda, the study design, and the micro- and macro-level data that native teams of researchers collected within each polity. This collection currently comprises data from surveys conducted during 1996-1998 in Australia, the Czech Republic, Great Britain, Israel, Lithuania, Poland, Romania, Spain, Taiwan, Ukraine, and the United States. The format includes a common questionnaire module and background (demographic) characteristics of respondents, coded to agreed-upon standards. These data have been merged into a single crossnational dataset with a companion supplementary weighted data file. Measures included in the study focus on three main issues. The first topic explored is the impact of electoral institutions, with questions about parliamentary versus presidential systems of government (levels of accountability, responsiveness), the electoral rules on casting/counting of votes (issues of fairness, impact of voting), and political parties (identification, ideological distinction). The second major issue covered is the nature of political and social cleavages and alignments, explored by questions such as left-right issue orientation of respondents vs. political parties. Lastly, the collection covers the evaluation of democratic institutions and processes through measures such as efficacy in political parties, elected officials, and respondents' satisfaction with democracy. Additionally, data were collected on voter turnout, voter choice, and respondents' age, sex, education, employment, and income.

National Health Interview Survey, 1996 — United States Department of Health and Human Services. National Center for Health Statistics (ICPSR 2661)

The purpose of the National Health Interview Survey (NHIS) is to obtain information about the amount and distribution of illness, its effects in terms of disability and chronic impairments, and the kinds of health services people receive. The variables in the Household Record file (Part 1) include type of living quarters, size of family, number of families in the household, presence of a telephone, number of unrelated individuals, and region. The Person Record file (Part 2) includes information on sex, age, race, marital status, Hispanic origin, education, veteran status, family income, family size, major activities, health status, activity limits, employment status, and industry and occupation. These variables are found in the Condition, Doctor Visit, and Hospital Record files as well. The Person Record also supplies data on height, weight, bed days, doctor visits, hospital stays, years at residence, and region variables. The Condition Record file (Part 3) contains information for each reported health condition, with specifics on injury and accident reports. The Doctor Visit Record file (Part 4) documents doctor visits within the time period and identifies acute or chronic conditions. The Hospital Record file (Part 5) provides information on medical conditions, hospital episodes, type of service, type of hospital ownership, date of admission and discharge, number of nights in hospital, and operations performed.

Pathways to Adulthood: A Three-Generation Urban Study, 1960– 1994: [Baltimore, Maryland] — Janet 8. Hardy and Sam Shapiro (ICPSR 2420)

This collection incorporates both prospective and retrospective data on three generations of families initially living in inner-city Baltimore, Maryland. The prospective data were selected from the Johns Hopkins Collaborative Perinatal Study (JHCPS), a survey of pregnant women (the firstgeneration mothers, abbreviated as G1) and the children born to them during 1960-1965 (the second-generation children, abbreviated as G2) at John Hopkins Hospital. The retrospective data come from a follow-up study. conducted in 1992-1994, of G1, G2, and the children born to G2 (the thirdgeneration children, abbreviated as G3). Data from JHCPS on G1 include obstetrical and reproductive history at registration for prenatal care, sociological/family history variables at or around delivery of G2 and when G2 was age 7, and observations of mother with child when G2 was 4 months old and 8 months old. For G2, the data from JHCPS include delivery room observations at birth, and clinical data at ages 4 months, 8 months, 12 months, 36 months, 48 months, 7-1/2 years, and 8 years. Retrospective data on G1 include variables on education, employment, family composition, health and health care usage, housing conditions, income and income sources, relationship history, neighborhood characteristics at registration to JHCPS and current, and reproductive history. For G2, data from the follow-up include information on aspirations, education, schooling, employment, family composition, health and health care usage, housing conditions, income and income sources, legal problems, living arrangements, relationship history, reproductive history, social relationships, smoking, and substance abuse. Data for the assessed third-generation children include information on cognitive development, academic achievement and behavior, prenatal care, health, day care, and parental aspirations.

The Treatment Episode Data Set (TEDS) is an administrative data system providing descriptive information about the national flow of admissions to providers of substance abuse treatment. The TEDS series was designed to provide annual data on the number and characteristics of persons admitted to public and private substance abuse treatment programs receiving public funding. The unit of analysis is treatment admissions. TEDS provides information on service setting, number of prior treatments, primary source of referral, employment status, whether methadone was prescribed in treatment, DSM-III-R codes, presence of psychiatric problems, living arrangements, source of income, health insurance, expected source of payment, substance(s) abused, route of administration, frequency of use, age at first use, pregnancy and veteran status, health insurance, and days waiting to enter treatment. Substances abused include alcohol, marijuana and hash, cocaine and crack, heroin and other opiates, PCP and other hallucinogens, stimulants, tranquilizers, barbiturates, inhalants, over-the-counter substances, and other. Demographic variables cover age, race, gender, income, marital status, and education. The public use files were created using the files that were current as of January 1998 (the 1/98 extract).
